Re: <u>Massachusetts Department of Transportation ("MassDOT") Service Plaza Lease – September 8 Records Production Contains Apparent Prohibited Communications and Conflicts</u>

Dear Secretary, Tibbits-Nutt and MassDOT Board Members:

Public records produced by your agency on September 8, 2025, copies of which are attached hereto as <u>Exhibit A</u>, establish that the Service Plaza Request for Proposals ("RFP") was compromised by prohibited ex parte communications and undisclosed conflicts of interest. These apparent violations strike directly at **Section 2.8 (Rules of Contact)** and **Section 2.10 (Improper Conduct)** of the Instructions to Proposers (as amended, "ITP"), which "are designed to promote a fair and unbiased procurement process." By the ITP's own terms, it appears that Applegreen should be immediately disqualified.

On August 29, 2025, I wrote to you outlining serious concerns about the RFP process. The September 8, 2025 document production corroborates these concerns. Texts confirm that Scott Bosworth, Head of the Selection Committee, engaged in repeated impermissible contact with Applegreen's owner, Blackstone Infrastructure Partners (via Applegreen Board Member Kurt Summers), executives of Suffolk Construction (a key member of Applegreen's Team), and Applegreen's registered lobbyist. If we are accurately reading these communications (and they are quite clear), not only do these communications violate the terms of the ITP, but no documentation has been produced (despite explicit requests) wherein the underlying relationships were properly disclosed (including in Scott Bosworth's Conflict Disclosure Statement dated as of November 22, 2024, attached as <u>Exhibit B</u>), despite being required under both the ITP and the Conflict of Interest Law.

Violations of Section 2.8 of ITP ("Rules of Contact")

Section 2.8 of the ITP establishes strict Rule of Contact "starting on the date of issuance of this RFP and ending on the earliest of (i) the award and execution of the Lease, (ii) rejection of all Initial Proposals or Proposals by MassDOT, or (iii) cancellation of the procurement." Per Section 2.8, "contact" includes face-to-face, telephone, e-mail, or formal written communication.

As part of the Rules of Contact, Section 2.8(C) of the ITP expressly prohibits any Proposer (as defined in the ITP) or representative thereof from having "any ex parte communications regarding the RFP, the Lease, or the procurement... with any MassDOT staff, advisors, contractors, or consultants involved in the procurement."

Furthermore, Section 2.8(B) of the ITP requires that each Proposer correspond with MassDOT regarding the RFP "only through MassDOT's Designated Program Representative and Proposer's designated representative". Pursuant to Section 2.4.1 of the ITP, MassDOT's Designated Program Representative is Michael Woods, Procurement Manager.

Yet the public records produced by MassDOT include the following communications¹ with Mr. Bosworth (who was **not** MassDOT's Designated Program Representative) during the time period in which the Rule of Conduct of the ITP were in effect:

- Blackstone/Applegreen Text Messages: the following communications occurred with Kurt Summers, President of Blackstone Infrastructure Strategies and Applegreen Board Member ("Kurt" or "KS")²:
 - o Text exchanges on March 26–31, May 15, May 30–31, and June 18, 2025, including calls, a lunch meeting, and a planned Martha's Vineyard meetup³.
 - On June 18, 2025, Mr. Bosworth texted Mr. Summers: "Your team did a good job today. Now the work begins ..."
 - o On July 9, 2025, Bosworth texted Mr. Summers what appears to be a personal email, although it has been redacted.
- Applegreen's Registered Lobbyist Texts and Calls: the following communications occurred with Carlo Basile, a registered lobbyist for Applegreen ("Carlo" or "CB"):
 - o Texts and calls on January 16, May 16, and June 11, 2025.
 - o On June 25, 2025, Mr. Bosworth texted Mr. Basile: "We and the Gov are getting hammered by legislators. We will need to jointly plan and administer legislative strategy."
- Suffolk Construction ("Suffolk") Communications: the following communications occurred with Patrick Brophy, Senior Director of External Affairs for Suffolk Construction ("Patrick" or "PB"), and Patrick Lucey, General Manager, Northeast of Suffolk Construction ("Patrick" or "PL"), including dozens of texts, calls and meetups:
 - o On December 11, 2024, Mr. Brophy attempted to reach Mr. Bosworth by phone. At 12:26 p.m., Mr. Bosworth texted Mr. Brophy, "Can I call you later? Hi! I'm in a selection committee meeting on Service Plaza's until 1:00. Call you after."
 - On February 25, 2025, Mr. Brophy invited Mr. Bosworth to a political fundraiser for Boston City Councilor John Fitzgerald, stating: "hope you can join me next Thursday for a drink".
 On February 27, 2025, Mr. Bosworth responded "It's on my calendar and I will do my best

- to be there". Mr. Brophy replied: "No pressure, just an opportunity to have a local beer w friends."
- o On March 11, 2025, Mr. Brophy requested a call with Mr. Bosworth for a "quick gut check." On March 14, 2025, Mr. Brophy thanked Mr. Bosworth for the "informative discussion earlier [that] week."
- o In April 2025, Mr. Bosworth arranged for an in-person meetup with Mr. Brophy and Mr. Lucey and other Suffolk representatives. Prior to the April 4, 2025 meetup, on April 3, 2025, Mr. Lucey describes some the Suffolk attendees as including "some of the BEST at Suffolk." (emphasis not added).
- On June 11, 2025, following the MassDOT Capital Planning Committee meeting regarding the RFP (and prior to the June 18, 2025 MassDOT Board Meeting), Mr. Bosworth texted Mr. Lucey the contact information for Jon Chesto (Boston Globe Reporter), noting "he posted a story a story don't sweat it." Mr. Lucey replied: "We already got it to him." Then, "will add". Note that there seems to be a gap in responses here as if messages were deleted.
- o On June 18, 2025, prior to the MassDOT Board meeting, Mr. Brophy texted Mr. Bosworth a list of speakers. Mr. Bosworth then texted Mr. Lucey: "You didn't sign up. Did you want to speak? Broph will be called on." After the vote, Mr. Bosworth texted Mr. Lucey: "Got it done," to which Mr. Lucey responded with a heart emoji.
- **John Fish Text Messages:** the following communications occurred with John Fish, Chief Executive Officer of Suffolk Construction ("**John**" or "**JF**"):
 - o On December 11, 2024, Mr. Fish attempted to reach Mr. Bosworth by phone. At 12:22 p.m., Mr. Bosworth replied, "Can I call you later? Hi! I'm in a selection committee meeting on Service Plaza's until 1:00. Call you after."
 - Additional regular contact between Mr. Bosworth and Mr. Fish occurred on or around key procurement dates, including without limitation, throughout April 2025. These texts include what appear to be personal favors, including the exchange of medical referrals and records, which would raise obvious and serious questions under Section 2.10.2, Personal Conflicts of Interest.
 - On December 10, 2024, Mr. Fish texted: "Scott I can't thank you enough for your support today. You are a true friend." indicating an ongoing, undisclosed personal relationship. On April 1, 2025, Mr. Bosworth texted to Mr. Fish "I welcome and so very much appreciate your offer to support me through this process. I am so grateful for your help, friendship and willingness to support me...."

Timing of Communications Around Key Meetings and RFP Milestones

June 11, 2025 – Capital Programs Committee Meeting

Between 9:33 and 9:36 a.m., before the Committee convened at 10:30 a.m., Mr. Bosworth sent " emojis to Suffolk executives Mr. Brophy and Mr. Lucey and to Applegreen lobbyist Mr. Basile. At 9:23 a.m., Global was notified it had not been selected — before the Committee had even met, indicating that Suffolk was receiving real-time updates from Mr. Bosworth as the outcome was being staged.

June 18, 2025 - MassDOT Board Meeting

The day of the vote (June 18, 2025), Mr. Brophy texted Mr. Bosworth: "just checking in..." Minutes before the meeting began, Mr. Brophy sent Mr. Bosworth a list of Applegreen, Suffolk, and Blackstone speakers along with a photo of the sign-up sheet. Immediately after the Board voted, Mr. Bosworth texted Mr. Lucey: "Got it done," and later told Mr. Summers: "Your team did a good job today. Now the work begins ..." While some texts seem to be deleted or omitted from the public records production, these texts suggest improper communication between the Head of the Selection Committee (i.e., Mr. Bosworth) and the winning bidder's team (i.e., Applegreen) during the most consequential moments of the procurement.

Apparent Violations of Section 2.10 of the ITP, Improper Conduct

- Section 2.10.1, Non-Collusion: Proposers were required to sign Form E, Affidavit of Non-Collusion. The texts and emails produced on September 8, 2025 quite clearly show extensive communication and coordination between Applegreen's team (Blackstone, Suffolk, and their lobbyist) and the Selection Committee Chair, calling into question the accuracy of Applegreen's Affidavit of Non-Collusion.
- Section 2.10.2, Personal Conflicts of Interest: Massachusetts General Laws, ch. 268A, requires all public officials to avoid conduct that creates, or *even appears to create*, favoritism or undue influence. Chapter 268A specifically prohibits public officials from using their positions to secure for themselves or others unwarranted privileges. During the Rules of Contact, Mr. Bosworth exchanged medical records and personal favors with Mr. Fish. Mr. Bosworth's personal ties extended further: on April 7, 2025, when Mr. Bosworth and Mr. Brophy exchanged family photos, including pictures of children at prom, and he maintained a notably close relationship with Applegreen Board Member Mr. Summers.

Despite these personal relationships, Mr. Bosworth signed a Conflict Disclosure Statement on November 22, 2024 certifying that "I do not have a conflict of interest, either real or apparent, as a result of (i) a business or personal relationship between myself or any member of my immediate family (and/or my employer... in any firm under consideration for the Project. I agree not to solicit or accept gifts, benefits, gratuities, unearned privileges or exemptions, favors, or anything of value from any firm under consideration for the Project." Schedule 1 of such Conflict Disclosure Statement included Suffolk Construction Company, Inc., as a firm under consideration, These undisclosed personal connections compounded one another, creating, at minimum, the appearance

of favoritism, and should have resulted in the disqualification of Applegreen's team from consideration.

What is most notable about these communications is not only their content, but their timing. At nearly every critical stage of the procurement process, when addenda were issued, when proposers were making their final submissions, when clarifications were sought on financial assumptions, and when committees and the MassDOT Board were preparing to deliberate, Mr. Bosworth, *Chair of the Selection Committee*, was in private contact with Applegreen's owner, Suffolk Construction executives, and Applegreen's lobbyist. *Exhibit C* provides a timeline of key milestones in the RFP process, with the corresponding communications overlaid, summarized below.

December 10, 2024 – Addendum 1 Issued

On the very day Addendum 1 of the RFP was released, Mr. Bosworth exchanged texts with Suffolk Construction CEO John Fish. Mr. Fish wrote: "Scott I can't thank you enough for your support today. You are a true friend." Mr. Bosworth replied: "Hopeful that we made progress!"

December 11, 2024 – Selection Committee Meeting and Suffolk Calls

During a Service Plaza Selection Committee meeting, Mr. Bosworth texted both Mr. Fish and Mr. Brophy that he was tied up in the meeting but would "*call after*."

Week of March 10, 2025 – MassDOT Meetings with Shortlisted Proposers

On the same day Global Partners LP (and presumably Applegreen that same week) met with the MassDOT, Mr. Bosworth began another round of contacts with Suffolk. On March 11, 2025, Mr. Brophy pressed Mr. Bosworth: "If/when you get a chance, can you pls give me a call?" Later: "Just a quick gut check." On March 14, 2025, Mr. Brophy thanked Mr. Bosworth for "our informative discussion earlier this week."

March 25, 2025 – Addendum 4 Issued and South Station Tour

When Addendum 4 of the ITP was issued, Mr. Bosworth set up a private tour of Suffolk's South Station Tower project. Mr. Lucey arranged to join with Suffolk senior staff, calling them "the BEST at Suffolk."

March 27, 2025 – Final Questions Due

On the final day for proposers to submit questions and organizational changes, Mr. Bosworth reached out directly to Suffolk CEO John Fish. Mr. Fish asked: "Can I call you later?" Mr. Bosworth replied: "Anytime. Thanks!"

April 1, 2025 – Addendum 5 Issued

On April 1, 2025, the deadline for final clarifications, Addendum 5 of the ITP was released. At the same time, Mr. Bosworth and Mr. Fish exchanged numerous texts about personal referrals, including Mr. Bosworth thanking Mr. Fish for supporting him regarding a medical situation.

May 15–16, 2025 – CapEx Clarifications and Blackstone Calls

On May 15, 2025, MassDOT asked all proposers to provide detailed information on projected post-Revitalization capital expenditures. As expressed in my previous letter, this key moment allowed Applegreen to put forward inflated numbers which MassDOT has relied on as justification for selecting them.

That same day, Mr. Bosworth texted Mr. Summers (Blackstone Senior Managing Director) and an Applegreen Board Member: "Hi Kurt! I'm just thinking of you and sending support your way." The two arranged a phone call for May 16, 2025.

Also on May 16, Bosworth texted Applegreen's lobbyist Carlo Basile: "Are you guys going out tonight? Call me if you are."

From the issuance of Addendum 1 of the ITP in December 2024 through the pivotal clarification on capital expenditures in May 2025, Mr. Bosworth's personal communications with Applegreen's team repeatedly aligned with the most consequential moments of the procurement. The record shows that members of the Applegreen team enjoyed a direct line to the Head of the Selection Committee during every stage of the process.

The Consequence Under the ITP

- Section 2.8(E) of the ITP: "Any communications determined by MassDOT to be improper may result in disqualification."
- Section 2.10 of the ITP: "Non-compliance with the terms of the Conflict of Interest Law shall constitute a material breach of this provision and may result in disqualification."

The September 8, 2025 public records production shows repeated violations of both provisions by members of the Applegreen's team and by the head of the MassDOT Selection Committee (Mr. Bosworth). Based on these improper communications, we believe Applegreen should be disqualified from the RFP.

Request for Immediate Action

Global Partners LP respectfully urges the Board to:

1. Halt execution of the Applegreen lease.

2. Disqualify Applegreen as a prospective operator under the RFP for violations of Sections 2.8 and 2.10 of the ITP.

This procurement was compromised by prohibited communications and undisclosed conflicts. Proceeding with Applegreen would not only cost the Commonwealth nearly \$900 million in guaranteed rent, but it would also knowingly ratify a process that we believe violates both the ITP and the Conflict of Interest Law.
